KONGA I - TALATEU

1 Hingoa nounou mo e Kamata ngaue'aki

- (1) 'E ui 'a e Lao ni ko e Lao 'a Tonga ki hono Fakamaau'i 'o e To'utupu 2024.
- (2) Kuo pau ke kamata ngaue'aki 'a e Lao ni 'i ha 'aho 'e fakaha 'e he Kapineti
pea pulusi 'i he Kasete 'a e Pule'anga 'o Tonga.

2 'Uhinga'i lea

'I he Lao ni tukukehe ka fiema'u ha 'uhiga kehe 'i hono tu'unga —

“taha lahi” koe'uhi ko e ngaahi taumu'a 'o e Lao ni 'oku 'uhinga ki ha taha
'oku ta'u 18 pe lahi hake 'i he ta'u 18;

- “**Ofisa Pule Ngaue**” ‘oku ‘uhinga ki he ‘Ofisa Pule Ngaue ‘o e Potungaue;
- “**tamasi'i pe taha kei si'i**” koe'uhi ko e ngaahi taumu'a 'o e Lao ni 'oku 'uhinga ki ha –
- (a) tamasi'i 'oku ta'u 7 pe lahi 'i he ta'u 7 pea 'oku si'i hifo 'i he ta'u 14 'a ia 'oku 'ave ki he founa ngaue Fakatonutonu 'o e To'utupu 'o fakatatau ki he Lao ki he Fakamaau'anga Polisi pe Lao 'o e Fakamaau'anga Lahi; pe
 - (b) taha kei si'i 'oku ta'u 14 pe lahi 'i he ta'u 14 pea 'oku si'i hifo 'i he ta'u 18;
- “**Fakamaau'anga**” tukukehe 'i hano fakamahino pau 'i he Lao ni, ko ha lave fakalukufua ki ha fakamaau'anga 'oku 'uhinga ia ki he Fakamaau'anga Polisi pe ko e Fakamaau'anga Lahi;
- “**ngaahi 'aho**” tukukehe 'i hano fakamahino pau 'i he Lao ni, 'oku 'uhinga ki he ngaahi 'aho fakatohimahina;
- “**Talekita**” ‘oku 'uhinga ki he the Talekita 'o e 'Ofisi Ngaue Fakatonutonu 'o e To'utupu 'a ia kuo fokotu'u 'i he kupu 15;
- “**ave**” koe'uhi ko e ngaahi taumu'a 'o e Lao ni, 'oku 'uhinga ki hono 'ave 'o ha tamasi'i pe taha kei si'i 'a ia kuo tukuaki'i na'a ne fakahoko ha hia mei he fakamaau'anga pea solova 'a e me'a ko ia 'o fou 'i he founa ngaue fakatonutonu 'o e to'utupu 'a ia kuo fokotu'u 'i he Lao ni;
- “**famili**” koe'uhi ko e ngaahi taumu'a 'o e Lao ni 'oku 'uhinga ki he matu'a pe ongo matu'a fakaenatula 'a e tamasi'i pe taha kei si'i, ongo matu'a ohi fakalao pe ohi fatungamotu'a pe ko e ongo tauhi fakalao, ongo tauhi pe kinautolu 'oku nau tokanga'i;
- “**Konifelenisi Fakakulupu 'a e Famili**” ‘oku 'uhinga ki ha Konifelenisi Fakakulupu 'a e Famili 'a ia kuo fakahoko 'i he Konga VII 'o e Lao ni;
- “**Fakataha 'a e Famili**” ‘oku 'uhinga ki he Fakataha 'a e Famili 'a ia kuo ui 'i he Konga VI 'o e Lao ni;
- “**Kasete**” ‘oku 'uhinga ki he Kasete 'a e Pule'anga 'o Tonga;
- “**Fakamaau'anga Polisi**” ‘oku 'uhinga ki he Fakamaau'anga Polisi kuo fokotu'u 'i he Lao ki he Fakamaau'anga Polisi (Vahe 3.12);
- “**Minisita**” ‘oku 'uhinga ki he Minisita Fakamaau'anga;
- “**Potungaue**” ‘oku 'uhinga ki he Potungaue Fakamaau'anga;
- “**Komiti Pule**” ‘oku 'uhinga ki he komiti kuo fokotu'u 'i he kupu 47 'o e Lao ni;
- “**Ofisa Polisi**” koe'uhi ko e ngaahi taumu'a 'o e Lao ni, 'oku 'uhinga ki he 'ofisa ma'u mafai 'o e Polisi Tonga 'i he Lao ki he Polisi Tonga [Vahe 7.07];

“**Ofisa Polisi Pule**” koe'uhi ko e ngaahi taumu'a 'o e Lao ni, 'oku 'uhinga ki he 'Ofisa Polisi 'a ia 'oku pule 'i ha keisi 'a ha tamasi'i pe taha kei si'i, 'a ia kuo 'ave ki he founga ngaue fakatonutonu 'o e to'utupu 'i he Lao ni;

“**Lao ki he Ngaue Fakapule'anga**” 'oku 'uhinga ki he Lao ki he Ngaue Fakapule'anga [Vahe 2.11];

“**taha toutou maumau lao**” koe'uhi ko e ngaahi taumu'a 'o e Lao ni 'oku 'uhinga ki ha tamasi'i pe taha kei si'i kuo ne kau ki he founga ngaue fakatonutonu 'o e to'utupu 'o 'ikai toe si'i hifo 'i he tu'o 3 'i ha ngaahi taimi kehekehe 'i loto 'i he vaha'a taimi ko e ta'u 'e ua;

“**taha fakahoko ngaue**” koe'uhi ko e ngaahi taumu'a 'o e Lao ni 'oku 'uhinga ki ha kautaha 'ikai fakapule'anga, ko ha sino pe taha taukei fakapalofesinale 'a ia ko ha kongia ia 'o ha ngaue 'i he Lao ni pe ko hono fakahoko ha ngaue 'o felave'i mo hono fakahoko 'o ha Palani Ngaue Fakatonutonu 'o e To'utupu;

“**Fakamaau'anga Lahi**” 'oku 'uhinga ki he the Fakamaau'anga Lahi kuo fokotu'u 'i he Lao ki he Fakamaau'anga Lahi [Vahe 3.16];

“**Palani Ngaue Fakatonutonu 'o e To'utupu**” 'oku 'uhinga ki ha palani kuo ngaue'aki 'o fakatatau mo e Konga VII 'o e Lao ni;

“**founga ngaue Fakatonutonu 'o e To'utupu**” 'oku 'uhinga ki he founga ngaue Fakatonutonu 'o e To'utupu 'a ia kuo fokotu'u 'i he Lao ni; mo e

“**Ofisa Fakatonutonu 'o e To'utupu**” 'oku 'uhinga ki ha 'ofisa kuo fakanofa 'i he kupu 15 'o e Lao ni.

3 Ngaahi taumu'a

Ko e ngaahi taumu'a 'o e Lao ni ke --

- (a) ta'ofi ha tamasi'i pe taha kei si'i 'a ia kuo tukuaki'i kuo ne fakahoko ha hia mei ha'ane kau atu ki he sisitemi fakamaau'anga hia;
- (b) fakahoko ha ngaue 'oku fe'unga mo e ta'u motu'a, fakalalakaka mo e anga fakafonua ki he faihia 'a e to'utupu;
- (c) fakasi'isi'i 'a e ngaue ki he fakamaau'anga 'aki hono 'ave 'o e ngaahi keisi iiki mei he ngaahi fakamaau'anga;
- (d) fakasi'isi'i 'a e faingamalie ke toe faihia mo fakahoko ha ngaue ki he ngaahi me'a 'oku ne fakatupu 'a e 'ulungaanga faihia 'aki hono fa'u 'o ha Ngaahi Palani Ngaue Fakatonutonu 'o e To'utupu 'a ia 'oku taau pea muimui'i;
- (e) 'oange ha faingamalie ki ha tamasi'i pe taha kei si'i ke ne mahino'i 'a e uesia mo e ngaahi nunu'a 'o 'ene ngaahi ngaue pea ke ne taliui ki ai;
- (f) 'oange ha faingamalie ki ha taha mamahi ke ne fakamamafa'i 'a e uesia 'o e 'ulungaanga faihia mo fo'u ha founga ki ha totongi huhu'i 'oku taau mo 'uhinga malie;

- (g) fakakau 'a e famili, siasi mo e komiuniti 'i he founa ngaue fakatonutonu 'o e to'utupu, ke fakatokanga'i mo toe fakamamafa'i 'a e mahu'inga 'o e famili, ko e fakakaukau 'o e *'fofolo e fala ka e alea 'a e kainga'* mo e tui faka-Kalisitiane ko e makatuliki 'o e sosaieti faka-Tonga; pea
- (h) faka'ai'ai 'a e fengaue'aki 'i he vaha'a 'o e pule'anga, siasi mo e ngaahi kautaha 'i he sosaieti ki he ni'ihiki kei si'i 'oku nau tu'u lavea ngofua.

4 Ngaahi tu'utu'uni tatakai

Kuo pau ke fakakaukau'i 'a e ngaahi tu'utu'uni tatakai ko 'eni 'e kinautolu 'oku faitu'utu'uni 'i hono fakahoko ha ngaahi tu'utu'uni 'i he Lao ni –

- (a) faka'ehi'ehi mei he ngaahi fakatonutonu hia 'i ha taimi pe 'e malava ai;
- (b) ngaue'aki ha ngaahi founa ngaue 'oku taau mo e anga fakafonua, ta'u motu'a mo e fakalalakaka ki ha tamasi'i pe taha kei si'i;
- (c) ngaue ki he tu'unga tu'u lavea ngofua 'o ha tamasi'i pe taha kei si'i 'aki hono 'oatu ha 'ataakai 'oku faipoupoua mo ha ngaahi naunau fe'unga ke ta'ofi 'aki ha'ane toe faihia;
- (d) fakakaukau'i 'a e lelei fakalukufua 'a e tamasi'i pe taha kei si'i ko e tefito'i me'a ke fakakaukau'i, fakataha mo hono fakatokanga'i 'o e ngaahi me'a 'oku lelei ki he taha mamahi;
- (e) tauhi 'a e tamasi'i pe taha kei si'i 'i he komiuniti pea ta'ofi 'ene kau atu ki he fakamaau'anga hia;
- (f) fakatokanga'i 'a e ta'u motu'a, fakalalakaka mo e puipuitu'a ko e ngaahi makatu'unga fakalelei;
- (g) ngaue'aki 'o e ngaahi tautea 'oku si'isi'i ange hono fakangatangata pea fakakau atu ki ai 'a e ngaahi tukunga 'o ha tamasi'i pe taha kei si'i 'i loto 'i he famili mo e komiuniti;
- (h) faka'apa'apa'i 'a e ngeia mo e mo'ui fakafo'ituitui 'o ha tamasi'i pe taha kei si'i 'i he taimi kotoa pe koe'uhi ke ta'ofi ha toe fakaluma'i mo hano fakamaa'i;
- (i) faka'ai'ai pea poupou'i 'a e tamasi'i pe taha kei si'i ke fakaha 'ene ngaahi fakakaukau 'i he 'ataakai 'o e founa ngaue fakatonutonu 'o e to'utupu kuo fokotu'u 'i he Lao ni; pea
- (j) fakapapau'i 'oku fakahoko mo fakakakato 'i he vave taha 'a e ngaahi founa ngaue 'i he Lao ni.

5 Ko e kau 'a e fanau ki he hia

Ko e ta'u motu'a 'o e faihia 'a e fanau kuo pau ke tatau mo 'ene ha 'i he kupu 16 'o e Lao ki he Ngaahi Hia.

KONGA II – PULE'I

6 Pule'i

Kuo pau ko e Minisita te ne tokanga'i hono pule'i 'o e Lao ni.

7 Ngaahi fatongia 'o e Minisita

- (1) Kuo pau ke ma'u 'e he Minisita 'a e ngaahi fatongia ko 'eni 'i he Lao ni –
 - (a) lipooti mo fale'i 'a e Kapinetai fekau'aki mo e ngaahi tu'utu'uni ngaue felave'i mo e fakamaau'i 'o e to'utupu mo e founa ngaue fakatonutonu 'o e to'utupu;
 - (b) fakapapau'i 'oku faipau 'a e kau 'ofisa faifatongia mo e ngaahi Potungaue mo e ngaahi sino fekau'aki mo honau ngaahi fatongia 'i he Lao ni mo e ngaahi tu'utu'uni kuo fa'u 'i he Lao ni;
 - (c) tauhi 'i he tu'unga ma'olunga, 'a e ngaahi va mo e ngaahi kautaha fekau'aki fakavaha'apule'anga mo e ngaahi hoangaue langa fakalalakaka 'a ia 'oku nau veveveke ke tokoni 'i hono fakahoko, tuku atu pe pule'i 'o e founa ngaue fakatonutonu 'o e to'utupu mo e ngaue ki he ngaahi kaveinga 'o e fakamaau'i 'o e to'utupu 'i Tonga; mo
 - (d) ha ngaahi fatongia kehe kuo fakamahino pau 'i he Lao ni.
- (2) Kapau 'e pehe 'e he Minisita 'oku 'aonga pe lelei ke fakakakato 'aki 'a e ngaahi fatongia 'o e Minisita 'i he Lao ni, 'e ngofua ke tu'utu'uni 'e he Minisita, 'i ha tohi, ke 'oatu 'e ha taha ha fakamatala, teita pe ha tohi 'o felave'i mo e –
 - (a) tukunga 'o ha tamasi'i pe taha kei si'i 'a ia 'oku 'ave ki he ngaue fakatonutonu 'o e to'utupu, 'o tatau ai pe 'i he tu'unga ki mu'a pe hili hono 'ave;
 - (b) ngaahi founa ngaue 'a ha taha pe ha kautaha 'o felave'i mo hono fakahoko 'o ha Palani Ngaue Fakatonutonu 'o e To'utupu; pe
 - (c) fakalalakaka 'o ha tamasi'i pe taha kei si'i 'i ha ako, komiumiti, ngaue'anga, pe polokalama kuo fakahoko 'e ha taha fakahoko ngaue, 'o tatau ai pe 'i he lolotonga pe hili 'a e founa ngaue fakatonutonu 'o e to'utupu.
- (3) Kuo pau ke ngaue'aki pau 'a e fakamatala kuo 'oatu ki he Minisita 'i he kupu si'i (2) ki hono fakahoko 'o e ngaahi fatongia 'o e Minisita 'i he Lao ni pea 'ikai ki ha toe taumu'a kehe.

8 Vahe'i

- (1) 'E ngofua ki he Minisita, mei he taimi ki he taimi, ke ne vahe'i hano fatongia 'e taha pe lahi ange pe ko hono ngaahi mafai 'i he Lao ni ki he 'Ofisa Pule Ngaue.
- (2) Neongo 'a e kupu si'i (1), kuo pau 'e 'ikai vahe'i 'e he Minisita hono mafai ke fakanoho 'i he kupu 15 'o e Lao ni.
- (3) Ko ha vahe'i 'i he kupu si'i (1) kuo pau ke –
 - (a) fakahoko 'i ha tohi;
 - (b) fakahoko ki he taha ko ia 'a ia 'oku vahe'i ki ai 'a e mafai;
 - (c) fakaha mahino 'a e ngaahi fatongia mo e mafai kuo vahe'i; pea
 - (d) fakaha 'a e 'aho kamata mo e 'aho faka'osi ki hono vahe'i 'o e ngaahi mafai.
- (4) Kuo pau ki ha tohingaue 'o e vahe'i ke 'i he foomu kuo tu'utu'uni 'i he Tepile 1 'o e Lao ni.
- (5) Kuo pau ke lekooti ha vahe'i 'i he lesisita 'a e Potungaue 'i he kupu 55 'o e Lao ni.
- (6) 'E ngofua ke fakata'e'aonga'i ha vahe'i 'e he Minisita 'aki ha tohi.

9 Ngaahi fatongia 'o e Potungaue

- (1) Kuo pau ke ma'u 'e he Potungaue 'a e ngaahi fatongia ko 'eni 'i he Lao ni –

TONGA YOUTH JUSTICE BILL 2024

A BILL TO ESTABLISH THE FRAMEWORK FOR A YOUTH JUSTICE SYSTEM FOR TONGA, TO DIVERT YOUNG PERSONS FROM THE FORMAL CRIMINAL JUSTICE SYSTEM, TO ADDRESS OFFENDING BY YOUNG PEOPLE IN AN APPROPRIATE MANNER AND FOR RELATED MATTERS

BE IT ENACTED by the King and Legislative Assembly of Tonga in the Legislature of the Kingdom as follows:

PART I – PRELIMINARY

1 Short title and Commencement

- (1) This Act may be cited as the Tonga Youth Justice Act 2024.
- (2) This Act shall come into force on a date proclaimed by Cabinet and published in the Tonga Government Gazette.

2 Interpretation

In this Act unless the context otherwise requires —

“adult” for the purposes of this Act means a person of or over the age of 18 years;

“CEO” means the Chief Executive Officer of the Ministry;

“child or young person” for the purposes of this Act means –

- (a) a child who is of or over the age of 7 years and under the age of 14 years who is referred to the Youth Diversion process in accordance with the Magistrate’s Court Act or Supreme Court Act; or
- (b) a young person who is of or over the age of 14 years and under the age of 18 years;

“Court” unless otherwise specified in this Act, a general reference to a court means a Magistrate’s Court or the Supreme Court;

“days” unless otherwise specified in this Act, means calendar days;

“Director” means the Director of the Youth Diversion Office appointed in section 15;

“diversion” for the purposes of this Act, means diverting a child or young person who is alleged to have committed an offence away from the formal justice system and resolving the matter through the youth diversion process which has been established under this Act;

“family” for the purposes of this Act means the biological parent or the child or young person’s legal adoptive or customary adoptive parents or legal guardians, guardians or caregivers;

“Family Group Conference” means a conference which has been convened under Part VII of this Act;

“Family Meeting” means a meeting that has been called under Part VI of this Act;

“Gazette” means the Tonga Government Gazette;

“Magistrate’s Court” means a Magistrate’s Court established under the Magistrate’s Court Act [Cap. 3.12];

“Minister” means the Minister of Justice;

“Ministry” means the Ministry of Justice;

“Oversight Committee” means the committee established in section 47 of this Act;

“Police Officer” for the purposes of this Act, means an authorised officer of Tonga Police under the Tonga Police Act [Cap 7.07];

“Police Officer in Charge” for the purposes of this Act, means the police officer who is in charge of a case involving a child or young person, which is referred to the youth diversion process under this Act;

“Public Service Act” means the Public Service Act [Cap 2.11];

“repeat offender” for the purposes of this Act means a child or young person who has participated in the youth diversion process at least 3 separate times within a two-year period;

“service provider” for the purposes of this Act means a non-government organisation, entity or qualified professional that is part of a process under this Act or providing a service in relation to the implementation of a Youth Diversion Plan;

“Supreme Court” means the Supreme Court established under the Supreme Court Act [Cap. 3.16];

“Youth Diversion Plan” means a plan adopted in accordance with Part VII of this Act;

“Youth Diversion process” means the process for Youth Diversion established under this Act; and

“Youth Diversion Officer” means an officer who has been designated under section 15 of this Act.

3 Objectives

The objectives of this Act are to –

- (a) prevent a child or young person who is alleged to have committed an offence from entering the formal criminal justice system;
- (b) provide an age, developmental and culturally appropriate response to youth offending;
- (c) reduce pressure on the court by diverting minor cases from the courts;
- (d) reduce the likelihood of re-offending and address the issues that have led to offending behaviour through the development of appropriate and monitored Youth Diversion Plans;
- (e) provide the opportunity for a child or young person to understand the impact and consequences of his actions and to take responsibility;
- (f) provide the opportunity for a victim to highlight the impact of the offending behaviour and create a pathway for practical and meaningful reparation;
- (g) involve family, church and community in the youth diversion process, recognising and reinforcing the importance of family, the concept of *‘fofola e fala ka e alea ‘a e kainga’* and the Christian faith as the cornerstone of Tongan society; and
- (h) promote cooperation between governmental, church and societal organisations in responding to young people who are at risk.

4 Guiding principles

The following principles shall be taken into account by decision makers when making decisions under this Act –

- (a) avoidance of formal criminal proceedings whenever possible;
- (b) utilising processes that are culturally, age and developmentally appropriate to the child or young person;
- (c) addressing the vulnerability of a child or young person by providing a supportive environment and the necessary tools to avoid re-offending;
- (d) considering the best interests of the child or young person as a primary consideration, with due regard to the victim's interests;
- (e) keeping a child or young person in the community and preventing entry into the formal criminal justice system;
- (f) recognising age, development and background as potential mitigating factors;
- (g) promoting sanctions that are the least restrictive and account for a child or young person's circumstances within the family and community;
- (h) respecting the dignity and privacy of a child or young person at all times in order to avoid further labelling and stigma;
- (i) encouraging and supporting a child or young person to express his views within the environment of the youth diversion process established under this Act; and
- (j) ensuring that procedures under the Act are conducted and completed speedily.

5 Criminal liability of children

The age of criminal liability of children shall be as stated in section 16 of the Criminal Offences Act.

PART II – ADMINISTRATION

6 Administration

The Minister shall be responsible for the administration of this Act.

7 Functions of the Minister

- (1) The Minister shall have the following functions under this Act –
 - (a) report to and advise Cabinet on policy matters relating to youth justice and the youth diversion process;

- (b) ensure compliance of responsible officers and relevant Ministries and entities with their obligations under this Act and regulations made under this Act;
 - (c) at a high level, foster relationships with relevant international organisations and development partners that are willing to assist with the implementation, delivery or administration of the youth diversion process and for addressing youth justice issues in Tonga; and
 - (d) any other function specified under this Act.
- (2) Where the Minister considers it necessary or desirable to fulfil the Minister's functions under this Act, the Minister may, in writing, require a person to provide information, data or documentation relating to –
- (a) the situation of a child or young person who is referred to youth diversion, whether before or after referral;
 - (b) procedures of a person or organisation in relation to the implementation of a Youth Diversion Plan; or
 - (c) the progress of a child or young person in any school, community, employment, or program provided by a service provider, whether during or following the youth diversion process.
- (3) Information provided to the Minister under subsection (2) shall be used specifically for discharging the functions of the Minister under this Act and not for any other purpose.

8 Delegation

- (1) The Minister may, from time to time, delegate one or more of his functions or powers under this Act to the CEO.
- (2) Notwithstanding subsection (1), the Minister shall not delegate his power of designation under section 15 of this Act.
- (3) A delegation under subsection (1) shall be –
 - (a) made in writing;
 - (b) communicated to the person to whom the power is delegate;
 - (c) state clearly the functions and powers that are being delegated; and
 - (d) state the effective date and end date for the delegation of powers.
- (4) An instrument of delegation shall be in the form prescribed in Schedule 1 of this Act.
- (5) A delegation shall be recorded in the register of the Ministry under section 55 of this Act.
- (6) A delegation may be revoked in writing by the Minister.

9 Functions of the Ministry

- (1) The Ministry shall have the following functions under this Act –
 - (a) provide and facilitate relevant training for officers and stakeholders involved with the implementation of this Act; and
 - (b) any other function that the Minister may determine from time to time, which is necessary for the effective implementation of this Act.
- (2) Functions of the Ministry shall be delivered through the CEO, Director and Youth Diversion Office.

10 Functions of the CEO

- (1) The CEO shall have the following functions under this Act –
 - (a) ensuring that the Youth Diversion Office has –
 - (i) the necessary financial and human resources for effective implementation of this Act; and
 - (ii) a succession plan for continuity of administration and the delivery of services as may be required;
 - (b) liaise with the Minister, Director and Oversight Committee to implement any changes or improvements required to the youth diversion process;
 - (c) recommend to the Minister suitable officers for designation as Youth Diversion Officers under section 15; and
 - (d) establish and maintain registers of the Ministry under section 55 of this Act.
- (2) The CEO shall have such powers as provided under this Act for the discharge of his functions.

PART III – ESTABLISHMENT OF THE YOUTH DIVERSION OFFICE**11 Establishment of the Office**

- (1) The Youth Diversion Office is hereby established.
- (2) The Youth Diversion Office shall be a division under the Ministry of Justice.

12 Functions of the Office

Functions and responsibilities of the Youth Diversion Office shall include –

- (a) implementing the youth diversion process established under this Act;

- (b) providing information and promoting awareness of youth justice issues to relevant stakeholders and members of the public;
- (c) addressing, in the first instance, any complaint from a child or young person, family members, Youth Diversion Officer, relevant stakeholder, or members of the public in relation to the implementation of any aspect of this Act; and
- (d) any other lawful directions of the Minister that are not inconsistent with the objectives of this Act.

13 Powers of officers

For the purposes of this Act, a Youth Diversion Officer shall have such powers as are necessary to carry out the functions of the Youth Diversion Office in section 12.

14 Functions of the Director

Functions and responsibilities of the Director shall include the following –

- (a) report to and make recommendations to the CEO in relation to the implementation and administration of this Act;
- (b) ensure the effective delivery of services and functions of the Youth Diversion Office;
- (c) provide information and promote awareness of youth justice issues to relevant stakeholders and members of the public; and
- (d) recommend suitable officers to be designated by the Minister under section 15.

PART IV – DESIGNATION OF YOUTH DIVERSION OFFICERS

15 Designation of officers

- (1) The Minister shall –
 - (a) on the recommendation of the CEO; and
 - (b) in relation to the designation of a public officer from another Ministry –
 - (i) with the written consent of that public officer's respective Chief Executive Officer; or
 - (ii) in the case of Tonga Police, with the written consent of the Police Commissioner,designate a person who is in the rank of sergeant or higher as a Youth Diversion Officer under this Act.

- (2) Notwithstanding any other provision to the contrary, the Director shall be deemed to be a Youth Diversion Officer under this Act.
- (3) A person who is recommended for designation under subsection (1) shall be a person who –
 - (a) is 25 years or older;
 - (b) has not been convicted of a criminal offence in Tonga or abroad;
 - (c) has displayed skills, qualities and work ethics which show that he will undertake his duties efficiently, effectively and honestly;
 - (d) has undertaken mandatory training facilitated by the Ministry for Youth Diversion Officers under this Act; and
 - (e) is a member of the public service or, if a person is from outside the public service, is eligible under this subsection and will be assigned a function under this Act.
- (4) A person who is designated under subsection (1) shall be issued with an instrument of designation, as evidence of being a designated Youth Diversion Officer under this Act.
- (5) A designation under subsection (1) shall be in the form prescribed in Schedule 2 of this Act.

16 Certificate of identity

- (1) A designated officer shall be issued with a certificate of identity in the form prescribed in Schedule 3 of this Act.
- (2) If requested by a person during any stage of the Youth Diversion Process, a designated officer shall present his certificate of identity, which shall be valid.
- (3) A person whose designation has been revoked under section 17 of this Act shall return his certificate of identity to the CEO immediately.

17 Revocation of designation

- (1) Prior to the expiration date of a Youth Diversion Officer's designation, the Minister may, on the recommendation of the CEO, revoke a designation by issuing to the person the instrument of revocation in the form prescribed in Schedule 4 of this Act.
- (2) Grounds for revoking an instrument of designation shall include –
 - (a) failure to follow the requirements of this Act;
 - (b) violation of a power issued under this Act;
 - (c) restructuring within the Ministry; or
 - (d) pursuant to the written request by a designated person's Chief Executive Officer.

- (3) In issuing the revocation, the Minister shall convey the following –
 - (a) reason for the revocation;
 - (b) effect date for the revocation; and
 - (c) an instruction to return the certificate of identity and any other property of the Ministry issued to the officer in the course of his duties.
- (4) If a designation has been revoked under subsection (1) and that person is a public officer who has been appointed under the Public Service Act, he may continue in his employment as an employee of the Ministry or any other Ministry, unless or until the Public Service Commission directs otherwise, in writing, to that officer's minister.

PART V – THE YOUTH DIVERSION PROCESS

18 Offences eligible for referral to the Youth Diversion Process

Subject to section 22, a child or young person who is alleged to have committed an offence in an Act listed in Schedule 5 for which the punishment is a maximum fine of \$10,000 or a term of imprisonment of up to 2 years, or both, shall be eligible for referral to the youth diversion process under this Act.

19 Criteria for referral of a child or young person

- (1) A child or young person is eligible for referral to the youth diversion process if the child or young person meets all of the following criteria –
 - (a) the child or young person is alleged to have committed an offence which is eligible for referral to the youth diversion process in accordance with section 18 of this Act;
 - (b) there is sufficient evidence that an offence has been committed;
 - (c) the child or young person is not a repeat offender; and
 - (d) it is in the interests of justice that the matter be resolved informally.
- (2) In determining whether diversion is in the interests of justice, the following factors shall be considered –
 - (a) nature, circumstances and seriousness of the offence;
 - (b) background and circumstances of the child or young person, including the child or young person's offending history;
 - (c) views of the victim;
 - (d) the need to ensure public safety; and
 - (e) guiding principles set out in section 4 of this Act.
- (3) In determining the age of the child or young person, the following documents shall be sufficient evidence –

- (a) birth certificate of the child or young person;
 - (b) certificate of live birth issued by a hospital or health clinic in Tonga or abroad; or
 - (c) in the absence of the official documents in subsections (3)(a) or (3)(b), the date of birth shown on the baptismal certificate of the child or young person or any other form of identification.
- (4) The process to be followed by Tonga Police when referring a child or young person to the youth diversion process under this Act shall be in the form prescribed in Schedule 7 of this Act.
- (5) A referral to the youth diversion process shall be made in the form prescribed in Schedule 8 of this Act.

20 Role of relevant stakeholders

The role of relevant stakeholders is set out in Schedule 9 of this Act.

21 Rights of the child or young person and family

- (1) During all stages of the Youth Diversion process, a child or young person and his family may request and receive –
- (a) clarification on any part of the process from a Youth Diversion Officer;
 - (b) independent legal advice; and
 - (c) the support and attendance of any family member or community representative.
- (2) For the purposes of subsection (1)(b), a child or young person and his family may seek independent legal advice at his or their own expense.

22 Mitigation

During the youth diversion process in section 18 or section 19 of this Act –

- (a) an apology or reparation provided by a child or young person to the victim; and
 - (b) the victim has accepted that apology or reparation,
- shall be considered as a mitigating factor during the Family Group Conference meeting.

23 Re-offending by a child or young person

- (1) Where a child or young person is alleged to have re-offended during the implementation of a Youth Diversion Plan, the Youth Diversion Officer, in consultation with the Police Officer in Charge of the matter, shall call a Type 3

Family Group Conference to determine the implications for the child or young person.

- (2) Notwithstanding subsection (1), the child or young person will be in accordance with this Act, assessed by the Police Officer in Charge as to whether the new alleged offending will qualify for the youth diversion process under this Act.

PART VI – FAMILY MEETINGS

24 Authority to call a Family Meeting

Upon receiving the referral form in Schedule 8 in relation to a child or young person from Tonga Police, a Youth Diversion Officer shall convene a Family Meeting with the child or young person and his family, agreeing on the date, venue and time for the meeting and to ensure that the child or young person and his family will be present.

25 Participants

Participants in a Family Meeting shall include the following –

- (a) child or young person who is the subject of the referral to the youth diversion process;
- (b) family of a child or young person;
- (c) youth diversion officer in charge of the matter; and
- (d) any other necessary participant.

26 Purpose

- (1) The purpose of a Family Meeting is for a Youth Diversion Officer to –
- (a) outline the youth diversion process and objectives for youth diversion to the child or young person and his family;
 - (b) outline the alleged summary of facts provided by Officer in Charge of the case and invite the child or young person to present his outline or explanation of event;
 - (c) invite the child or young person and his family to participate in the youth diversion process;
 - (d) respond to questions from the child or young person and his family, ensuring they are informed about the process and what to expect; and
 - (e) where the child or young person elects to participate in the youth diversion process, prepare the child or young person and his family for participating in the Family Group Conference.
- (2) Where, pursuant to subsection (1)(b), a child or young person has raised an objection or requests a correction to the alleged summary of facts, the Youth

Diversion Officer will discuss this further with the Police Officer in Charge of the case, so that any changes can be made to the summary of facts prior to the Family Group Conference.

27 Location and proceedings of a Family Meeting

- (1) A Family Meeting may take place in any place agreed to by the Youth Diversion Officer and the family.
- (2) Proceedings in a Family Meeting shall be determined by the Youth Diversion Office.

28 Election of process

- (1) A child or young person, together with his family, shall have the right to elect whether to take part in the youth diversion process under this Act.
- (2) At the end of a Family Meeting, a Youth Diversion officer shall invite, within a prescribed period, the child or young person to elect whether or not to take part in the youth diversion process in respect of the alleged offending.
- (3) Where a decision is made by a child or young person, together with his family, not to take part in the youth diversion process, the matter shall be processed by the Tonga Police for prosecution in the usual manner.

29 Consent form to be completed

- (1) Where, pursuant to section 28, a child or young person and his family elects or elect to participate in the youth diversion process under this Act, a Youth Diversion Officer shall provide the consent form in the form prescribed in Schedule 6 of this Act for the family to complete and sign.
- (2) Where a child or young person and his family disagree on whether to take part in the youth diversion process, a Youth Diversion Officer shall –
 - (a) make every reasonable effort to understand the reason or reasons for the divergence of views;
 - (b) facilitate further discussions between the child or young person and his family; and
 - (c) encourage the child or young person and his family to reach a consensus on their decision.
- (3) Where a child or young person and his family continue to have diverging views on whether to take part in the youth diversion process, the decision of the child or young person's –
 - (a) biological parents;
 - (b) adoptive parents, in the case where a child or young person has been legally adopted;

- (c) legal guardians, in the case where a child or young person is under a legal guardianship order; or
 - (d) father or mother, in the case of a single parent family,
will take precedence over the consent of the child or young person.
- (4) Notwithstanding subsection (3), where a child or young person elects to take part in the youth diversion process but is not supported by his biological parent, parents, adoptive parents or guardians in subsection (3) –
- (a) a Magistrate Court judge, upon application by a Youth Diversion Officer on behalf of a child or young person appearing before him, may remit the matter to the youth diversion process in accordance with the Magistrates Courts Act; or
 - (b) a Supreme Court judge, upon application by a Youth Diversion Officer on behalf of a child or young person appearing before him, may remit the matter to the youth diversion process in accordance with the Supreme Court Act.

30 Record of a Family Meeting

- (1) A Youth Diversion Officer shall keep an accurate record of what was agreed at a Family Meeting, for inclusion in a child or young person's file.
- (2) At the Family Group Conference, the Youth Diversion Officer shall present the main issues covered and any matters agreed during the Family Meeting.

PART VII – FAMILY GROUP CONFERENCE

31 Authority to convene a Family Group Conference

- (1) A Youth Diversion Officer shall have the authority to call a Family Group Conference.
- (2) A Family Group Conference shall be held –
 - (a) no later than 2 weeks following a Family Meeting; and
 - (b) at a venue in the child or young person's village, which shall not include a police station or a courthouse.
- (3) Matters in a Family Group Conference shall be discussed in confidence, with due consideration for the rights of the child or the young person and also the impact of the offending on the victim(s).

32 Types of Family Group Conference

- (1) There shall be three types of Family Group Conferences –

- (a) Type 1 Family Group Conference;
 - (b) Type 2 Family Group Conference; and
 - (c) Type 3 Family Group Conference.
- (2) The purpose for each type of conference shall be in the form prescribed in Schedule 10 of this Act.

33 Participants

- (1) The following participants shall attend a Family Group Conference –
- (a) child or young person who is the subject of the referral to the youth diversion process and his parents or caregivers;
 - (b) Youth Diversion Officer responsible for the case;
 - (c) Police Officer in Charge who was responsible for making the referral or his nominee; and
 - (d) Town Officer of the village in which the Family Group Conference is taking place.
- (2) In addition to the persons referred to in subsection (1), a Youth Diversion Officer, in consultation with the Police Officer in Charge in subsection (1)(c), may invite the following participants to a Family Group Conference –
- (a) victim or victims of the offending behaviour, accompanied by a family member if the victim is a minor;
 - (b) church representative;
 - (c) representative from the child or young person's –
 - (i) current or former school; or
 - (ii) current or former post-secondary institution;
 - (d) representative from a school, post-secondary institution in which the child or young person intends to enrol;
 - (e) representative of a service provider;
 - (f) youth leader or youth worker who has a good relationship with the child or young person and who has good standing within the local community; or
 - (g) any other person that the Youth Diversion Officer or the child or young person and his family wish to invite to the Family Group Conference.
- (3) A victim, regardless of age, shall have the right to have a support person at a Family Group Conference, provided that the Youth Diversion Officer has been informed of the name and details of the support person prior to the meeting and that person is appropriate to attend.
- (4) Media personnel shall not be allowed to attend a Family Group Conference, unless attending as a direct family member of a person directly involved in the proceedings.

- (5) A law practitioner representing a child or young person may attend a Family Group Conference at the request of the child or young person and his family, although to the extent possible, legal personnel should not be encouraged to participate at this stage.
- (6) An officer of Tonga Police or other representative from a law enforcement agency shall not attend at Family Group Conference in uniform.

34 Purpose

- (1) Purpose for convening a Family Group Conference is, subject to a child or young person's response to an allegation or allegations, to –
 - (a) inform participants of the circumstances of the alleged offence and seek the participants' –
 - (i) advice, counsel and guidance for the child or young person; and
 - (ii) views on an appropriate Youth Diversion Plan;
 - (b) develop and agree upon a Youth Diversion Plan for the child or young person in response to the offending behaviour;
 - (c) hold the child or young person accountable for their actions, assist them to consider why it happened and to help the child or young person gain an understanding of the harm or damage caused to the victim and to enable the child or young person to take responsibility for the offending behaviour;
 - (d) help the child or young person 'right the wrong', assisting them to consider what can be done to put things right and support the child or young person through any reparation or restitution; and
 - (e) support the child or young person in making positive life changes, addressing the underlying causes that lead to offending and reducing the likelihood of re-offending in the future.
- (2) Where there is –
 - (a) a successful completion of the Youth Diversion Plan by a child or young person, there will be no further action by the Youth Diversion Office or Tonga Police; or
 - (b) an unsuccessful or partial completion of a Youth Diversion Plan by a child or young person, the child or young person's case will be transferred back to Tonga Police for a decision on further action.

35 Location and proceedings of a Family Group Conference

- (1) Subject to subsection (2), a Family Group Conference shall take place in the child or young person's village.
- (2) Where a child or young person ordinarily resides in a village, district or island away from his family, a Family Group Conference may take place –

- (a) in the village, district or island where the child or young person ordinarily resides; or
- (b) where, in the opinion of the Youth Diversion Officer, is most convenient for the participants in a Family Group Conference to meet, for reasons of logistics, affordability or convenience.

36 Options for a Youth Diversion Plan

- (1) In the development of a Youth Diversion Plan, the following options shall be available to the Family Group Conference –
 - (a) warning to the child or young person;
 - (b) an oral or written apology by the child or young person to the victim or victims;
 - (c) monitored school attendance for a specified period of time;
 - (d) compliance with any conference-imposed conditions or standards of behaviour;
 - (e) compliance with any curfew imposed;
 - (f) requirement to report to a specified person or organisation at specified times for supervision, monitoring, mentoring;
 - (g) counselling by a specified person or organisation, such as counselling for alcohol and drug issues, anger management or mental health issues with an appropriate service provider;
 - (h) requirement to enrol in a programme such as vocational or skills training or rehabilitation;
 - (i) restitution including the return of any items taken;
 - (j) recompense for any injury or loss caused by the child or young person;
 - (k) reparation of any damage done by the child or young person;
 - (l) the provision of a specified service by the child or young person to the victim or victims, with the consent of the victim;
 - (m) community service of an appropriate type in an appropriate setting; or
 - (n) any other measure deemed appropriate to the child or young person and the local circumstances.
- (2) A Youth Diversion Plan shall be in the form prescribed in Schedule 11 of this Act.
- (3) If required, a Youth Diversion Plan shall be translated into the English language by the Youth Diversion Office.

37 Requirements for a Youth Diversion Plan

- (1) A Youth Diversion Plan shall be –

- (a) appropriate to the age of the child or young person;
 - (b) proportionate to the offence alleged to have been committed by the child or young person;
 - (c) flexible enough to allow for any changes in the circumstances of the child or young person and his family; and
 - (d) subject to section 38 of this Act, confirmed by the consensus of participants attending the Family Group Conference.
- (2) A Youth Diversion Plan shall not –
- (a) be harmful to the child or young person’s physical or mental health;
 - (b) involve corporal punishment, public humiliation, or anything that would degrade or stigmatise the child or young person;
 - (c) involve any form of deprivation of the child or young person’s liberty; or
 - (d) interfere with the child or young person’s schooling.
- (3) To the extent possible, the Youth Diversion Plan shall –
- (a) impart useful skills to the child or young person;
 - (b) address underlying issues that contributed to the child or young person’s offending behaviour;
 - (c) include a restorative justice element aimed at restoring the relationship between the child or young person, the victim and the community; and
 - (d) involve the family and community members in holding the child or young person accountable and addressing the offending behaviour.
- (4) A copy of the Youth Diversion Plan shall be provided to the following –
- (a) child or young person and his family;
 - (b) each person who is responsible for implementing and monitoring the Youth Diversion Plan; and
 - (c) Police Officer in Charge who was responsible for making the referral to the Youth Diversion Office.
- (5) A Youth Diversion Plan shall stipulate the persons responsible for supervising and monitoring the implementation of the Youth Diversion Plan.

38 Lack of consensus

Where, despite full discussions, the participants in the Family Group Conference fail to reach a consensus on a particular issue or on the nature of a Youth Diversion Plan, the Youth Diversion Officer shall have the right to make a final decision based on the best interests of the child or young person in order to facilitate an outcome or a Youth Diversion Plan that is practical and appropriate for the child or young person.

39 Record of a Family Group Conference

- (1) A Youth Diversion Officer who leads a Family Group Conference shall ensure that there is an accurate record of the proceedings of a Family Group Conference.
- (2) The record in subsection (1) shall be kept in the file of the child or young person which is held at the Youth Diversion Office, with a copy provided to the Police Officer in Charge of the case, or the Police Officer in attendance.
- (3) A record in subsection (1) shall be in the form prescribed in Schedule 12 of this Act.

40 Application to vary a Youth Diversion Plan

- (1) A Youth Diversion Officer may, in writing, apply to the Director for a variation of an agreed Youth Diversion Plan.
- (2) An application for the variation of a Youth Diversion Plan shall be in the form prescribed in Schedule 13 of this Act.
- (3) In determining whether or not to grant an application under subsection (1), the Director shall consider the following –
 - (a) nature of the variation;
 - (b) reasons for the request for variation;
 - (c) support by the child or young person and his family for the variation;
 - (d) if applicable, support by the Family Group Conference; and
 - (e) whether the child or young person has generally been in compliance with the Youth Diversion Plan prior to the application.
- (4) The Director shall, within 3 working days of an application being lodged under subsection (1), issue a written decision to the Youth Diversion Officer, with a copy provided to the –
 - (a) child or young person and his parents or caregivers;
 - (b) Police Officer in Charge who responsible for making the referral; and
 - (c) Town Officer or person responsible for monitoring the plan.
- (5) An Order varying a Youth Diversion Plan shall be in the form prescribed in Schedule 14 of this Act.

PART VIII – IMPLEMENTATION OF A YOUTH DIVERSION PLAN

41 Responsibilities for supervising and monitoring

- (1) The responsibilities of a person from the community who is assigned to supervise, assist or deliver services for a child or young person in relation to a Youth Diversion Plan, shall be clearly stipulated, either in the Youth Diversion Plan or in a written communication from a Youth Diversion Officer.
- (2) A Youth Diversion Officer shall be assigned by the Director to closely monitor the activities under subsection (1) and to record the activities in a child or young person's file.
- (3) To the extent possible, where a child or young person is a female, a female shall be assigned to supervise or monitor a child or young person who is fulfilling the requirements of a Youth Diversion Plan.
- (4) Where a person in subsection (1) or a Youth Diversion Officer in subsection (2) fails to conduct, supervise or monitor the tasks which they were assigned in a Youth Diversion Plan, resulting in the non-completion of the Youth Diversion Plan by the child or young person, –
 - (a) this lack of support shall be raised, verbally or in writing, by the family of the child or young person to the CEO of the Ministry;
 - (b) the CEO shall assign one or more persons to supervise the completion of the Youth Diversion Plan by the child or young person within a prescribed period; and
 - (c) the child or young person shall not be penalised for non-completion of the Youth Diversion Plan.

42 Family to remain informed

- (1) The Youth Diversion Officer responsible for each case shall keep a child or young person's family informed on the commencement, duration, requirements, and conditions of the child or young person's Youth Diversion Plan.
- (2) Prior to any change in the implementation of a Plan, a Youth Diversion Officer shall advise a child or young person's family.
- (3) Unless a child or young person objects, a child or young person's family shall be entitled to accompany a child or young person to carry out or attend a programme under a Youth Diversion Plan.

43 Duties of a child or young person

- (1) A child or young person shall comply with all requirements of a Youth Diversion Plan, once adopted under Part VII.
- (2) A child or young person shall attend any community service, counselling programme, church activity, or make an apology or provide reparation in the manner or on the date directed by his supervisor or Youth Diversion Officer, pursuant to his Youth Diversion Plan.
- (3) If a child or young person or his family wish to vary his attendance on a particular date, the child or young person shall contact and obtain the approval of his Youth Diversion Officer at least 48 hours prior to the date of the activity.
- (4) Where a date for an activity has been varied under subsection (3), the Youth Diversion Officer shall record the reasons for the change and the new date on which the activity shall be carried out and convey this to the child or young person's supervisor at the earliest opportunity.

44 Advice of Completion

- (1) At the successful completion of a Youth Diversion Plan by a child or young person, the Youth Diversion Officer shall, in consultation with all stakeholders who were involved in the youth diversion advise the Director of the completion of the youth diversion process.
- (2) Upon receiving the advice in subsection (1) -
 - (a) the Director shall in writing, submit an Advice of Completion to the Police Officer in Charge who was responsible for the referral; and
 - (b) upon receiving the request from the Director, the Police Officer in Charge who was responsible for the referral shall record this in the child or young person's file and take no further action against the child or young person.
- (3) An Advice of Completion shall be in the form prescribed in Schedule 15 of this Act.

45 Advice of Non-Completion

- (1) Where a child or young person has failed to comply with or complete a Youth Diversion Plan, a Youth Diversion Officer shall, in consultation with all stakeholders who were involved in the Family Group Conference, advise the Director of the non-completion of the youth diversion process.
- (2) Upon receiving the advice in subsection (1), the Director shall, in writing, notify the Police Officer in Charge who was responsible for the referral, and the child or young person referred back to the formal court process.

- (3) An Advice of Non-Completion shall be in the form prescribed in Schedule 16 of this Act.

46 Reasons for non-completion

Where a child or young person does not complete a Youth Diversion Plan, the reasons for non-completion shall be recorded by a Youth Diversion Officer in sufficient detail to assist in the successful monitoring and strengthening of the youth diversion process.

PART IX – MONITORING OF THE YOUTH DIVERSION PROCESS

47 Establishment of an Oversight Committee

- (1) The Minister shall establish an Oversight Committee to be responsible for monitoring the implementation of this Act.
- (2) The Oversight Committee shall be comprised of the following members –
 - (a) Chief Magistrate (chair);
 - (b) Police Commissioner;
 - (c) Solicitor General; and
 - (d) CEO of the Ministry.
- (3) The Oversight Committee may, from time to time, co-opt any additional members as it may require, for the discharge of its functions.
- (4) The term for each member of the Oversight Committee shall be, for a –
 - (a) person holding an *ex-officio* position, for as long as that person holds the position;
 - (b) non-Government representative or a co-opted person, for a period of two years, with the possibility of reappointment by the Oversight Committee for one additional term.
- (5) A person shall not be co-opted to the Oversight Committee unless he has –
 - (a) knowledge of or experience in the justice sector in Tonga or the Pacific; or
 - (b) specialised skills or knowledge that are relevant to the functions of the Oversight Committee.
- (6) The Ministry shall provide the secretariat duties for the Oversight Committee.

48 Functions of the Oversight Committee

The Oversight Committee shall have the following functions –

- (a) monitor the implementation of the Act by relevant stakeholders to ensure compliance with this Act and regulations made under it;
- (b) assess outcomes for young people who have completed the youth diversion process to see whether any changes should be made to the process, and provide recommendations to the Minister as applicable;
- (c) consider and make recommendations to the Minister in relation to –
 - (i) a complaint lodged under section 50 of this Act; or
 - (ii) strengthening the legal, regulatory and policy framework for youth justice in Tonga; or
- (d) any other function that the Minister may request on the Oversight Committee from time to time.

49 Recommendations of the Oversight Committee

- (1) Recommendations of the Oversight Committee under Parts IX and X of this Act shall be carefully considered by the Minister and, if the Minister approves the recommendations, they shall be implemented.
- (2) The CEO shall be responsible for overseeing the implementation of recommendations which are approved by the Minister under subsection (1).

PART X – COMPLAINTS PROCEDURE

50 Complaint may be lodged

- (1) A child or young person and his family may lodge a complaint in writing to the Oversight Committee about a process, decision made, or treatment of a child or young person under this Act.
- (2) A complaint shall be –
 - (a) in the form prescribed in Schedule 17 of this Act; and
 - (b) submitted to the Secretariat of the Oversight Committee within 21 days of the grievance occurring or the decision being made.

51 Consideration of a complaint

- (1) The Oversight Committee shall meet as and when required to determine a complaint which has been lodged under this Part.
- (2) If required, the Oversight Committee shall obtain additional information from the complainant or person who is the subject of the complaint.

- (3) The Oversight Committee shall issue its decision within 28 days of the complaint being lodged or, where additional information was requested, within 28 days of receiving the full information it required.
- (4) The Ministry shall provide the resources required by the Oversight Committee to carry out its functions under this Part.

PART XI – CONFIDENTIALITY OF FILES

52 Confidentiality

The proceedings and outcome of a Family Meeting and Family Group Conference shall be kept strictly confidential except in the following circumstances –

- (a) to the extent that information shall be shared with participants who have agreed to help implement or monitor parts of the Youth Diversion Plan; or
- (b) where a child or young person continues to re-offend and is processed by the Court in accordance with applicable law.

53 Name suppression

- (1) There shall be automatic suppression of the name of a child or young person who is –
 - (a) referred to and participating in the youth diversion process; or
 - (b) appearing before the Magistrates Court or Supreme Court in relation to any matter which involves a child or young person, unless the court determines that there are exceptional circumstances requiring the name suppression to be lifted.
- (2) For the purposes of subsection (1), exceptional circumstances shall include that the child or young person –
 - (a) has been convicted of a serious crime that in the public interest, it would be unreasonable to withhold the name and identity of the child or young person; or
 - (b) is a repeat offender who has been previously convicted and imprisoned for criminal offences.

PART XII – FINANCIAL MATTERS

54 Fees and other entitlements

The Minister may, in consultation with Cabinet, approve or establish any meeting fee, reimbursable expense or entitlement of any person, entity or committee for a function or assigned responsibility under this Act.

PART XIII – REGISTER

55 Register to be established

- (1) The Director shall, within 12 months of the commencement of this Act, establish and maintain a register containing the following information –
- (a) power that has been delegated by the Minister to the CEO in section 8 of this Act;
 - (b) name of each child or young person that has been referred to the youth diversion process in section 18 and section 19 of this Act;
 - (c) prior police record of a child or young person who has been referred to youth diversion, if any;
 - (d) names of the Youth Diversion Officer, Police Officer in Charge, town officer and community stakeholders involved at each stage of the youth diversion process in respect of each child or young person's Youth Diversion Plan that has been adopted in relation to each child or young person and in particular –
 - (i) whether the plan was fully completed or not completed;
 - (ii) if not completed, reasons for the non-completion;
 - (iii) if not completed, whether a variation order was applied for and the new conditions under the variation order;
 - (iv) if there was a variation order, whether the Youth Diversion Plan was fully completed or not completed; and
 - (v) any recommendations for further refining and strengthening the youth diversion process in Tonga;
 - (e) name of a Youth Diversion Officer who has been designated under section 15 of this Act, as well as evidence of training and police clearance;
 - (g) name of a Youth Diversion Officer whose designation has been revoked under section 17 of this Act;
 - (h) name and information relating to a service provider that provides or delivers a service under this Act, including the names and background checks of each of their authorised officers;

- (i) in relation to paragraph (h), information on whether the service provider has complied, or continues to comply, with minimum standards prescribed in regulations made under this Act or the national child protection policy which has been approved by Cabinet;
 - (j) complaints that have been lodged under section 50 of this Act, including the nature and outcome of each complaint; and
 - (k) any other item or record that the Director shall deem necessary to be included in the register.
- (2) To the extent possible, the register established in subsection (1) shall be maintained electronically.

PART XIV – MISCELLANEOUS

56 Protection from liability

No action shall be taken against an officer or member of an entity or body established under this Act, for an act which was done in good faith or is purported to have been done by the officer or member in the performance of that officer or member's duties or discharge of functions under this Act.

57 Power to make regulations

The Minister shall, with the consent of Cabinet, make regulations for the effective implementation of this Act.

PART XV – OFFENCES AND PENALTIES

58 Failure to provide accurate information and obstruction

A person who —

- (a) knowingly provides false, outdated or inaccurate information to the Ministry, Youth Diversion Office or a designated officer under this Act;
- (b) wilfully fails to give information or to produce any document lawfully requested by the Ministry or a designated officer under the provisions of this Act; or
- (c) obstructs a designated officer in the exercise of his powers or duties under this Act,

shall be liable on conviction to a fine not exceeding \$2,000 or a term of imprisonment of up to 3 months, or both.

59 Child or young person not to be mistreated

- (1) A child or young person shall not be mistreated by a person performing a function during any stage of the youth diversion process under this Act.
- (2) A person who violates subsection (1) is liable, upon conviction, to a fine not exceeding \$5,000 or to a term of imprisonment of up to 6 months, or to both.

3 Referral

Where a child or young person is eligible for youth diversion under section 18 and section 19 of this Act, the Police Officer in Charge shall make the written referral for submission to the Director of the Youth Diversion Office.

4 Family Meeting

- (1) If Tonga Police refers the case of a child or young person to the Youth Diversion Process under this Act, the child or young person and his family shall be advised of this, and remain informed throughout all stages of the Youth Diversion Process.
- (2) A Youth Diversion Officer shall arrange a Family Meeting with the child or young person and his family within 1 week of the referral being received.

SCHEDULE 9*(Section 20)***ROLE OF RELEVANT STAKEHOLDERS**

The role of relevant line Ministries and community stakeholders in the youth diversion process is outlined below.

1 Tonga Police

- (1) The role of the Police Officer in Charge who deals with a child or young person who is alleged to have committed an offence which is eligible for referral to the youth diversion process, shall include the following –
 - (a) be the first contact with the child or young person and gather contact information;
 - (b) undertake initial contact with family to inform them regarding the child or young person and offence or offences alleged to have been committed;
 - (c) determine if the child or young person meets the criteria for referral;
 - (d) inform the child or young person and family about the youth diversion process;
 - (e) complete and send referral to the Director of the Youth Diversion Office;
 - (f) prepare and share information with the Youth Diversion Office prior to the Family Meeting and the Family Group Conference;
 - (g) ensure that written or electronic records are kept of the referral of the child or young person, including the following:
 - (i) notes of investigation;
 - (ii) criteria for eligibility and evidence that the child or young person met the criteria for referral to the youth diversion process;
 - (iii) decisions reached; and
 - (iv) referrals made.
 - (h) attend a Family Group Conference and contribute to the formulation of a Youth Diversion Plan.
- (2) Information to be shared in subsection (1)(f) include –
 - (a) statement of facts and the alleged offence or offences by the child or young person;
 - (b) a summary of damage or harm caused; and
 - (c) any victim or witness statement.

2 Town Officers

Subject to the approval of the responsible Chief Executive Officer, the role of a Town Officer shall include the following –

- (a) liaise with Youth Diversion Office over arrangements for the Family Group Conference;
- (b) support a Youth Diversion Officer in making practical arrangements for a Family Group Conference, including provision of an appropriate venue within the village or accessing local support services appropriate to the needs of the child or young person;
- (c) provide relevant input into the Family Group Conference on the effects of any harm or damage to the community due to the alleged offending;
- (d) advise on or assist with the provision of any locally based programme that forms a part of the Youth Diversion Plan;
- (e) contribute to the formulation of a Youth Diversion Plan;
- (f) if requested by the Family Group Conference, supervise the child or young person during the implementation of a Youth Diversion Plan or, in consultation with a Youth Diversion Officer, facilitate other arrangements; and
- (g) if requested, provide general support for the child or young person and his family.

3 Service Providers

- (1) A service provider may volunteer its services to assist in the Youth Diversion Process by registering with the Ministry in the prescribed manner.
- (2) The role of a service provider may include the following –
 - (a) if requested by a Youth Diversion Officer, participate in a Family Group Conference;
 - (b) contribute to the formulation of a Youth Diversion Plan; and
 - (c) provide a programme of support or deliver a service to help the child or young person to address underlying issues in order to make better life choices, so as not to re-offend.

4 Church and community representatives

- (1) A church or community organisation in the child or young person's village may volunteer its services to assist in the Youth Diversion Process by registering with the Ministry in the prescribed manner.
- (2) The role of a church or community representative may include the following –
 - (a) if requested, participate in a Family Group Conference;
 - (b) present the church or community's view of the harm or damage caused;

- (c) contribute to the formulation of a Youth Diversion Plan; and
- (d) provide spiritual support or a programme of support to help the child or young person make better life choices, so as not to re-offend.

5 Family

The role of a child or young person's family shall include the following –

- (a) attend the Family Meeting and Family Group Conference convened by the Youth Diversion Office;
- (b) support the child or young person at any meeting or interview during the Youth Diversion Process;
- (c) discuss the effect of the child or young person's offending.
- (d) contribute to the formulation of the Youth Diversion Plan and enable the child or young person to complete it; and
- (e) at the completion of the Youth Diversion Plan, acknowledge the outcome, or where there is non-completion, continue to support the child or young person in the next steps of the process.

EXPLANATORY NOTES

(These notes do not form part of the Bill and is only intended to explain its scope and purpose)

- 1.1 The primary purposes for this Bill are to –
- (a) prevent a child or young person alleged to have committed an offence from entering the formal criminal justice system and the adverse consequences which follow;
 - (b) provide an age, developmental and culturally appropriate response to youth offending;
 - (c) reduce pressure on the court system by diverting minor cases from the courts; and
 - (d) reduce the likelihood of a child or young person re-offending by addressing the issues that have led to offending behaviour, through the development of an appropriate and monitored Youth Diversion Plan.
- 1.2 This Bill should be read in conjunction with the following amendment Bills, which seek to make consequential amendments to relevant laws, to align with the Youth Diversion Process established under this Bill –
Magistrate’s Court (Amendment) Bill 2024, Supreme Court (Amendment) Bill 2024, Tonga Police (Amendment) Bill 2024 and the District and Town Officers (Amendment) Bill 2024.
- 1.3 The table below outlines the main parts and sections of the Tonga Youth Justice Bill 2024 –

PART IN BILL	EXPLANATORY NOTE
Part I – Preliminary	This Part sets out the short title, commencement and interpretation sections. Section 3 sets out the objectives of the Bill while section 4 establishes guiding principles to be considered by decision makers when making decisions under the Bill.
Part II – Administration	This Part establishes the framework for the administration of the Bill. The Minister of Justice is responsible for administration of this Bill (section 6) and the Minister’s functions prescribed (section 7). The Minister is able to delegate one or more of his functions to the Chief Executive Officer of the Ministry (section 8). Functions of the Ministry are outlined (section 9) as well as functions of the Chief Executive Officer in (section 10).

Part III – Establishment of the Youth Diversion Office	This Part establishes the Youth Diversion Office. Statutory functions of the Youth Diversion Office are outlined (section 12) as well as powers of designated youth diversion officers (section 13). The Director and staff of the Youth Diversion Office are to be appointed in accordance with the Public Service Act (section 14).
Part IV – Designation of Youth Diversion Officers	This Part outlines the process for the designation of a Youth Diversion Officer. The Minister of Justice is empowered to designate a Youth Diversion Officer from within the Ministry of Justice on the recommendation of the Chief Executive Officer (section 15(1)(a)). The Minister is also empowered to designate a Youth Diversion Officer from another Ministry, provided that the Minister responsible for the public officer consents (s15(1)(b)). Criteria for the selection of a person as a Youth Diversion Officer are outlined in section 15(3).
Part V – The Youth Diversion Process	This Part establishes the Youth Diversion Process. The two key sections are sections 18 and 19, which lists the offences which are eligible for referral to youth diversion as well as criteria for the child or young person to be eligible for youth diversion.
Part VI – Family Meetings	This Part outlines the participants (section 25) and proceedings (section 27) in a Family Meeting, as well as the objectives (section 26). Following a Family Meeting, a child or young person and his family must provide written consent to take part in the youth diversion process (section 29)).
Part VII – Family Group Conference	This Part outlines the participants (section 33) and proceedings (section 35) in a Family Group Conference, as well as the objectives (section 34). The participants in a Family Group Conference must, by consensus, develop a Youth Diversion Plan in relation to a child or young person who is taking part in the Youth Diversion Process (section 36). Among other things, the Youth Diversion Plan must be appropriate to the age and maturity of the child or young person, proportionate to the alleged offence and flexible enough to allow for any change in the circumstances of the child or young person and his family (section 37).
Part VIII – Implementation of a Youth Diversion Plan	This Part outlines the requirements for implementation of a Youth Diversion Plan. The Director must assign a Youth Diversion Officer to monitor the implementation of a Youth Diversion Plan (section 41) and ensure that

	<p>the child or young person's family remains informed during implementation (section 42).</p> <p>A child or young person must fulfil all the requirements in the Youth Diversion Plan (section 43). Where a Youth Diversion Plan is fully completed by a child or young person, the Director will advise Tonga Police with an Advice of Completion (section 44) and that is the end of the matter. Where a Youth Diversion Plan is not fully completed by the child or young person, the Director will advise Tonga Police (section 45) with an Advice of Non-Completion and Tonga Police shall process the child or young person in the usual manner, in accordance with applicable laws.</p>
Part IX – Monitoring of the Youth Diversion Process	<p>This Part deals with monitoring of the Youth Diversion Process. Section 47 establishes an Oversight Committee which is responsible for monitoring the youth diversion process and making recommendations to the Minister for its strengthening and improvement. Members of the Oversight Committee are – the Lord Chief Justice (chair), Chief Police Magistrate (deputy chair), Chief Executive Officer of the Ministry of Justice, Police Commissioner and Solicitor General (section 47(2)). The Secretary of the Oversight Committee shall be appointed by the Oversight Committee from the Ministry.</p>
Part X – Complaints Procedure	<p>This Part establishes a complaints procedure under the Bill. A child or young person and his family may lodge a complaint about a process, decision made, or treatment of a child or young person who is referred to the Youth Diversion Process (section 50). Section 51 outlines the process to be followed when considering a complaint.</p>
Part XI – Confidentiality of Files	<p>This Part requires that proceedings and outcomes of a family meeting and family group conference must be kept confidential (section 52) for the protection of the child or young person. Section 53 requires automatic name suppression for a child or young person who is appearing before a Magistrate's Court or the Supreme Court on any matter, except where the Court determines otherwise.</p>
Part XII – Financial Matters	<p>This Part deals with the entitlement of persons who are assigned with responsibilities under the Bill, to meeting fees or other forms of remuneration (section 54).</p>

Part XIII – Register	This Part requires the Director of the Youth Diversion Office to establish and maintain a register to record data and information in relation to the implementation of the Youth Diversion Process under this Bill (section 55).
Part XIV – Miscellaneous	This Part deals with two miscellaneous issues including the protection from liability of an officer or member of an entity or body established under this Act (section 56) and the provision of the Minister’s power to promulgate regulations under the Act, with the consent of Cabinet (section 57).
Part XVII – Offences and Penalties	This Part sets out offences and penalties under the Bill.
Schedule 1 – Instrument of Delegation	This Schedule prescribes the instrument by which the Minister may delegate one or more of his powers to the Chief Executive Officer of the Ministry.
Schedule 2 – Designation of a Youth Diversion Officer	This Schedule prescribes the instrument of designation of a Youth Diversion Officer.
Schedule 3 – Form of Identification of a Youth Diversion Officer	This Schedule prescribes the form of identification of a Youth Diversion Officer.
Schedule 4 – Revocation of Designation of a Youth Diversion Officer	This Schedule prescribes the instrument of revocation of the designation of a Youth Diversion Officer.
Schedule 5 – Offences eligible for referral to Youth Diversion	This Schedule outlines the list of laws and threshold by which a child or young person shall be eligible for referral to the youth diversion process.
Schedule 6 – Consent Form to participate in the Youth Diversion Process	This Schedule prescribes the consent form by which a child or young person and his family agrees to take part in the youth diversion process.
Schedule 7 – Referral of a Child or Young Person by Tonga Police to the Youth Diversion Process	This Schedule outlines the process to be followed by Tonga Police when determining whether to refer a child or young person, alleged to have committed an offence, to the youth diversion process.
Schedule 8 – Youth Diversion Referral Form	This Schedule prescribes the form to be used by Tonga Police when referring a child or young person to the youth diversion process.

Schedule 9 – Role of Relevant Stakeholders	This Schedule outlines the roles of relevant line ministries and community stakeholders in the youth diversion process.
Schedule 10 – Types of Family Group Conferences	This Schedule outlines the types of Family Group Conferences.
Schedule 11 – Youth Diversion Plan Template	This Schedule prescribes the template for a Youth Diversion Plan.
Schedule 12 – Record of a Family Group Conference	This Schedule prescribes the template for a record of a Family Group Conference.
Schedule 13 – Application for Variation of a Youth Diversion Plan	This Schedule prescribes the form for an application to vary a youth diversion plan.
